SPCKAPPA is our parent company, holding 50.57% of our voting rights.

In addition, COLOWODE (TSE Prime Market) is a holding company that holds 100% of the common shares of SPC Kappa and is the parent company of our company.

We are a member of the COLOWIDE Group, which consists of COLOWIDE and its 103 consolidated subsidiaries. The Group is engaged in the operation of directly managed restaurant chains, multi-store franchise operations, catering service business, and the provision of various food products and manufactured and processed goods.

Our company is part of the COLOWIDE Group, a corporate group that includes our parent company,

etc. and we operate restaurants that handle "fresh fish" as part of the Group's strategic business portfolio. We conduct our business in cooperation with our parent company and other Group companies, but we are an independent company with a certain degree of independence.

4. Matters concerning transactions with controlling shareholders, etc.

Our company has a business relationship with a subsidiary of COLOWIDE for the purchase of food ingredients and consumables, and the terms and conditions of our transactions with each company are determined in the same manner as those for general business relationships.

Regarding our relationship with the COLOWIDE Group, including COLOWIDE, we maintain independence as a fundamental principle. Transactions with the COLOWIDE Group are reviewed and deliberated by a special committee composed of independent individuals, including independent outside directors, established for the purpose of protecting the interests of minority shareholders and ensuring fairness and equity for shareholders. The committee considers market prices and other factors, submits its findings to the board of directors, and decisions are made following board approval.
